RESOLUTION 2024/25 #5A

WHEREAS, the Wastewater Ordinance of the Porter Vista Public Utility District, Section 8-02, provides that the Board of Directors shall, by Resolution, set the fees for sewerage service;

WHEREAS, the Board of Directors finds the monthly sewerage rates are necessary for the purpose of meeting operating expenses, including employee wage rates and fringe benefits, purchasing or leasing supplies, equipment or materials, meeting financial reserve needs and requirements and obtaining funds for capital projects necessary to maintain service within the existing service area.

WHEREAS, on June 12, 2024, the Board of Directors determined and approved not to increase the sewer rates pursuant to Proposition 218 guidelines.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Porter Vista Public Utility District that commencing June 12, 2024, the single family dwelling rate for the District shall be \$14.75 per Single Family Dwelling.

LET IT BE FURTHER RESOLVED that all non-residential single-family dwelling sewer rates shall be proportionately increased in commensurate with the increase in the sewer rate.

WHEREAS, on June 8, 2018, the Board of Directors determined and approved that the sewer rate for large retail stores shall be added to the categories of the District at \$25.50 per month.


